

PRIVACY POLICY OF THE WWW.MEDICALCONTINENCECENTERS.EU

I. GENERAL INFORMATION

1. The Operator of the Service www.medicalcontinencecenters.eu (hereinafter called the “**Service**”) is Medical Contenance Centers S.A., with its registered office in Warsaw, ul. Chmielna 132/134, 00-805 Warsaw, entered in the Register of Businesses of the National Court Register maintained by the District Court for the Capital City of Warsaw, 13th Business Department of the National Court Register (KRS), with the reference number KRS 0000743658, with share capital of PLN 204,814.00, assigned a tax identification number (NIP): 118-217-86-31 and a statistical business identification number (REGON): 380961096.
2. The Service acquires information about Users and their behaviour through:
 - voluntarily completed forms;
 - placing cookies on end devices;
 - web server logs gathered by a hosting operator functioning at www.medicalcontinencecenters.eu.

II. INFORMATION ON FORMS

1. The Service collects information voluntarily given by Users.
2. The Service may also store information about the connection’s parameters (duration, IP address).
3. Data on forms is not made available to any third parties other than with the User’s consent.
4. Data provided in forms may constitute a list of prospective customers, entered by the Service Operator in the register maintained by the Personal Data Protection Office.
5. Data provided in forms is processed for the purpose arising from a specific form’s function, among other things, to process service requests or business contacts.
6. Data provided in forms may be transferred to technical entities which render certain services. In particular, this concerns the transfer of information about the owner of a registered domain to entities which are operators of internet domains, payment services or other entities with which the Service Operator cooperates in such matters.

III. INFORMATION ABOUT COOKIES

1. This Service uses cookies.
2. Cookies are IT data, in particular text files, stored on the end device of the Service User and intended for using the Service’s web pages. Cookies usually contain the name of the web page they come from, how long they have been stored on the end device and a unique number.
3. The entity placing cookies on the end device of the Service User and gaining access to them is the Service operator.
4. Cookies are used for the following purposes:
 - to prepare statistics which help to understand how Service Users use webpages, which enables their structure and contents to be improved;
 - to maintain the Service User’s session (after log in) thanks to which the User does not have to re-enter their login and password on each Service subpage;

- ▶ to define the User's profile in order to display customized materials in advertising networks for them, in particular the Google network.
- 5. Two basic types of cookies are used on the Service: session cookies and persistent cookies.
- 6. "Session" cookies are temporary files which are stored on the User's end device until they log out, leave the webpage or close the software (web browser). "Persistent" cookies are stored on the User's end device for the period of time specified in the cookies' parameters or until they are deleted by the User.
- 7. The software used to browse web pages (a web browser) usually allows cookies to be stored on the User's end device by default. Service Users can change these settings. Web browsers enable cookies to be deleted. Cookies may also be blocked automatically. Detailed information about this can be found in the Help section or documentation of your web browser.
- 8. Restricting the use of cookies may affect certain functionalities available on the Service's web pages.
- 9. Cookies placed on the end device of the Service User may also be used by the advertisers and partners cooperating with the Service operator.
- 10. Cookies may be used by advertising networks, in particular the Google network, to display advertisements matching the manner in which the User uses the Service. To this end, they may keep information about the User's navigation path or the time spent on a given page.
- 11. As regards information about the User's preferences, collected by the Google advertising network, the User may view and edit the information in cookies by using the following tool: www.google.com/ads/preferences/.

IV. SERVER LOGS

1. Information about certain types of User behaviour is logged at server level. This data is used exclusively to administer the Service and to provide the most effective hosting services possible.
2. Viewed items are identified by their URL address. Other information stored may include:
 - ▶ time of request;
 - ▶ time of response;
 - ▶ name of the client's station - the identification is carried out by the HTTP protocol;
 - ▶ information about errors which occurred in carrying out the HTTP transaction;
 - ▶ the URL address of the previous page visited by the User (a referer link) - where the Service is arrived at via a link;
 - ▶ information about the User's browser;
 - ▶ information about the IP address.
3. The above data is not identifiable with specific individuals browsing the pages.
4. The above data is used exclusively for the purposes of Service administration.

V. PROVIDING ACCESS TO DATA

1. Data is made available to third parties exclusively within the limits of the law.
2. Data enabling an individual to be identified is only made available with that person's consent.
3. The Operator may be obliged to provide the information collected by the Service to authorized bodies on the basis of legitimate requests, to the extent specified in a request.

VI. COOKIES MANAGEMENT

1. If the User does not wish to receive cookies, they can change their browser settings. You should bear in mind that disabling cookies necessary for the authentication, security, and maintaining User preferences may obstruct and, in extreme cases, render the use of web pages impossible.
2. Detailed information about the possibility and ways of handling cookies is available in software (web browser) settings.
3. The User may delete cookies at any time by using the functions available in the web browser they use.
4. Restricting the use of cookies may affect some of the functionalities available on the Service website.
